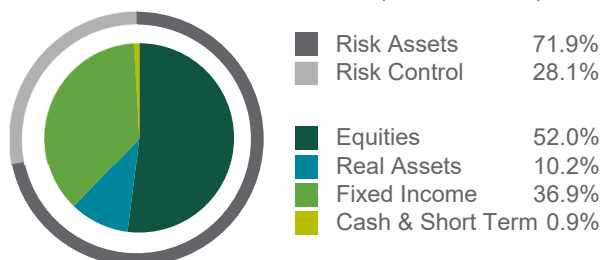

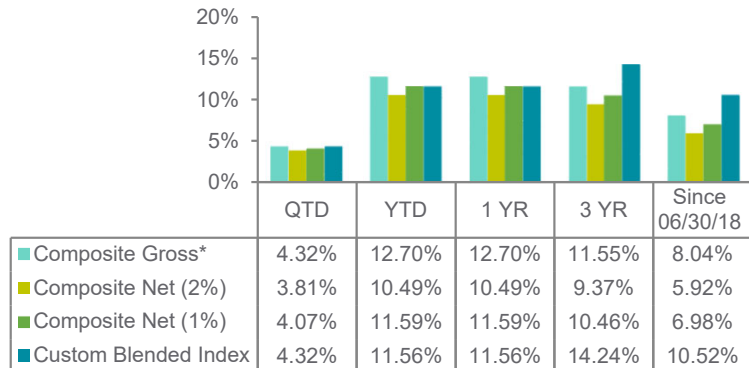

It utilizes a balanced multi-asset class strategy that includes tactical asset allocation with a risk profile approximating that of The Custom Blended Index shown below. The strategy invests primarily in various equity and fixed income pooled funds. The composite was created in June 2018. The composite inception date is 06/30/2018.

The internal dispersion of annual gross returns is measured by the standard deviation across asset-weighted portfolio returns represented in the composite for the full year. 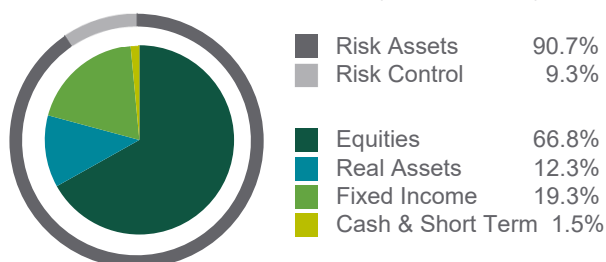

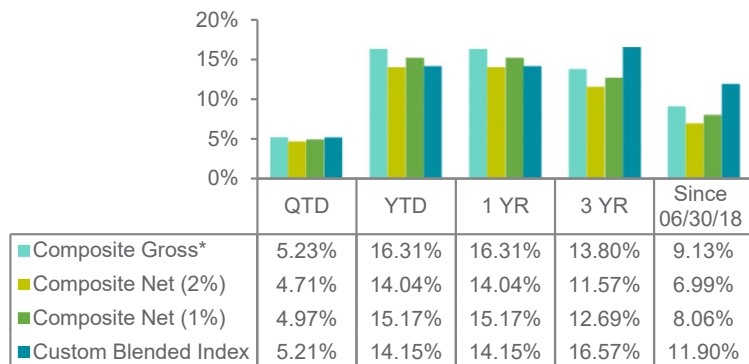

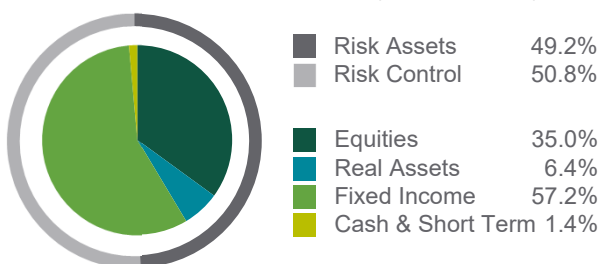

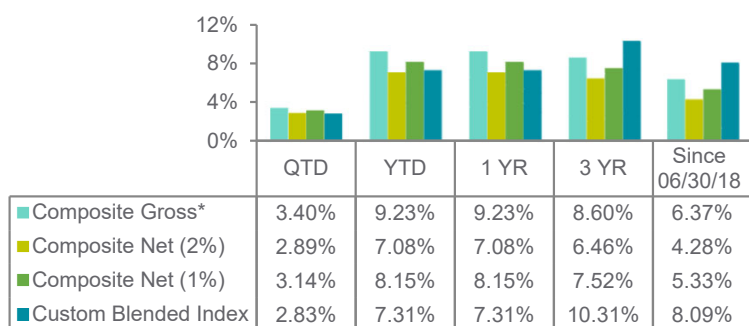

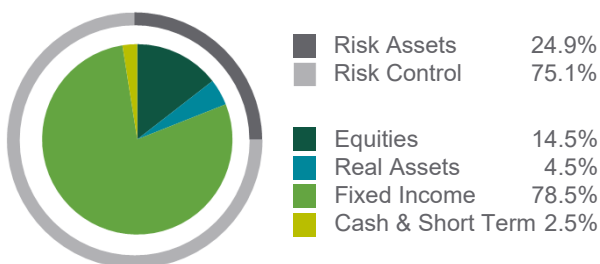

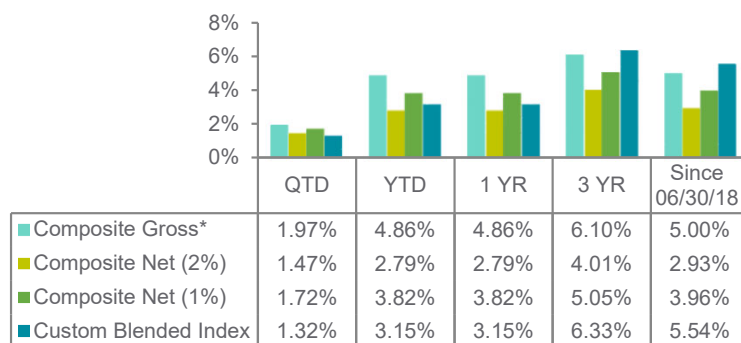

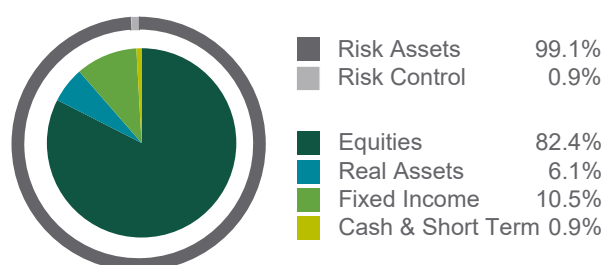

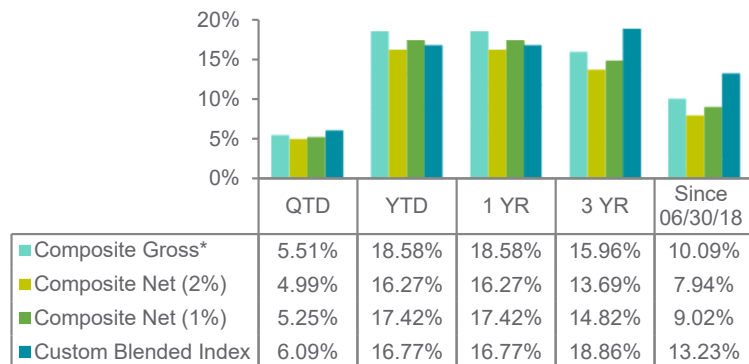

**Description:** The composite consists of all fee-paying and non-fee paying, fully discretionary Diversified Strategist Portfolios Maximum Growth Tax Sensitive portfolios designed for investors seeking long-term capital appreciation with minimal consideration for tax-exempt income. It utilizes a balanced multi-asset class strategy that includes tactical asset allocation with a risk profile approximating that of The Custom Blended Index shown below. The strategy invests primarily in various equity and fixed income pooled funds. The composite was created in June 2018. The composite inception date is 06/30/2018.

The internal dispersion of annual gross returns is measured by the standard deviation across asset-weighted portfolio returns represented in the composite for the full year. If fewer than 5 portfolios are in the composite for a full year, internal dispersion is deemed not applicable. The trailing 3-year risk is defined as the standard deviation of the trailing 36 monthly gross returns annualized. If the composite has been open for less than three years, the three-year annualized standard deviation is deemed not applicable. Performance results (or fees) are provided by NTI.
